

### Future of CCPA - N.S. in danger

In late January 2006, the CCPA Nova Scotia received devastating news from the National Executive. We had expected that the National Office would allow a permissible deficit for the 2006 budget while we continue efforts to find sufficient funds to sustain CCPA-NS.


Since all revenue from individual memberships (bar \$5,000) remains in the National budget, CCPA-NS's efforts are directed toward increased support from organizations. The good news is that past revenues show that organizational revenues are increasing. Unfortunately, the current rate of growth indicates that its unlikely self-sufficiency will be achieved before several additional years pass.

Our budget is based on the full time employment of a provincial director and fair employment practices that set salary and benefits based on a blended formula of administrative and research positions at the National Office Level. The Steering Committee believes that stable, full time, full year employment is absolutely

necessary to the ongoing success of CCPA in Nova Scotia. This year's projected budget shows that about 81 percent (\$65,692.27) of all expenses (\$70,992.27) at CCPA-NS relate to our full-time employee.

While we continue to

meet with key sponsors to encourage increased support, we are also continuing a debate with the National Board. We are arguing that an annual cost of \$15,000 per year can be viewed as a modest outlay for a National organization hopeful of establishing a permanent presence for a very productive provincial office.

Each Steering Committee Member wants to see deficits related to the Nova Scotia end as soon as possible. There is no thought on any member's part that the financial commitment of the CCPA National does not exact a toll on other potential projects and areas of growth. We look forward to a time when revenues generated in Nova Scotia will cover all costs

related to Nova Scotia activities.

A thorough discussion of our current financial circumstances will be lead at this year's Annual General Meeting. Key to this will be assessing the feasibility of moving forward with reduced staffing for the Nova Scotia Office.

We need full participation from individual and organizational members in Nova Scotia and are urging everyone to

attend this year's AGM. Broad participation by the membership is needed to forward this discussion. Your input could be crucial to the future of the Nova Scotia Office.

Our Winters of Discontent by Larry Hughes, March 20, 2006 This report presents a strategy for home-heating that is focused on long term energy security. Hughes offers a succinct critique of current approaches by governments. This report is a careful examination of home heating in Nova Scotia and some startling statistics are presented.

Fairness in Education for Single Parents in Nova Scotia, by Katherine Reed, December 14, 2005 This report is the first detailed examination of income and expenses for single parentuniversity students in Nova Scotia. The budgets of several hypothetical single parent families are presented in light of various programs and student loans. Nova Scotia Child Poverty Report Card: 1989-2003 by

Pauline Raven & Lesley Frank, November 29, 2005 This report shows that child poverty in Nova Scotia has increased for the fourth year running reaching a high by 2003 of 20.7 percent.
