1<sup>st</sup> place: Manitoba (up from 3<sup>rd</sup> in MP4, edging out Quebec which falls to 2<sup>nd</sup>) 10<sup>th</sup> place: Nova Scotia (maintains last place ranking after falling from 9<sup>th</sup> to 10<sup>th</sup> in MP4)

# **Most improved**

Manitoba (from 3<sup>rd</sup> to 1<sup>st</sup>) and Saskatchewan (from 7<sup>th</sup> to 4<sup>th</sup>) Greatest decline overall: Prince Edward Island (from 5<sup>th</sup> to 9<sup>th</sup>)

### **Trends to watch**

BC's slide from 1<sup>st</sup> (MP and MP2) to 4<sup>th</sup> (MP4) to 6<sup>th</sup> in MP5 Quebec's slide from 1<sup>st</sup> to 2<sup>nd</sup> place Newfoundland's stabilization at 3<sup>rd</sup> place as the effect of tuition fee freeze

Newfoundland's stabilization at 3<sup>rd</sup> place as the effect of tuition fee freezes and rollbacks in that province are felt

# **Tuition Fees**

Highest average university tuition fees (2003/4): Nova Scotia at \$5,557 Lowest average university tuition fees (2003/4): Quebec at \$1,862

Highest average college tuition fees (2003/4): Saskatchewan at \$2,893 Lowest average college tuition fees (2003/4): Quebec at \$0 (for Cégeps)

Change in average university tuition fees (2002/3-2003/4): 4.5% rollback for Newfoundland Change in average university tuition fees (2002/3-2003/4): 30.4% increase for BC Change in average college tuition fees (2002/3-2003/4): 38.4% increase for BC

#### Debt

In real terms, student debt at graduation has increased by close to 100% for college, bachelor and masters graduates and almost tripled for doctorates (since the early 1990s).

# **Public opinion**

- % of respondents to an Ipsos-Reid poll (April 2004) who believe PSE is "only for the affluent": 80%
- % of respondents to a Decima/CAUT poll (November 2003) who believe today's tuition fees "are keeping qualified people from getting a post-secondary education": 70%
- % of respondents to a Feedback Research poll who feel Ontario's tuition fees are too high: 63%
- ....who support a university tuition fee freeze across the province: 70%
- ....who are very or somewhat concerned about accessibility of higher education in Ontario: 80%
